- ♥ Nominee cannot be a prior recipient.
- ♥ Please state the reasons why your nominee fits the description of having a "Heart of Gold."
- ♥ Be sure to address the concerns listed in this brochure under "Selection Criteria."
- ♥ Be sure your nomination form is turned in to the DCF Office by **4 p.m. Tuesday OCTOBER 2, 2018**
- ♥ Please note that your narrative should be suitable for a public audience and may be made available to local newspapers.

Dearborn County residents, regardless of age, who enhance the quality of life of someone else are eligible to be nominated.

Such acts of service may largely go unnoticed and include, but are not limited to: helping senior citizens, helping disadvantaged persons, working to improve the quality of education, expanding recreational and cultural opportunities, working with children, protecting the environment, promoting public safety, and unusual acts of kindness.

What "Selection Criteria" are Heart of Gold Awards based upon?

When making its choice, the Selection Committee will take into account whether the nominee:

- ♥ Identifies a need and fulfills it.
- ♥ Recognizes opportunities and acts upon them.
- ♥ Shares their time and energy for the sake of others.
- ♥ Overcomes unusual challenges to serve others.
- ♥ Renders a service which changes a life.
- ♥ Works to create positive change.
- ♥ Inspires others to volunteer.
- ♥ Performs an exceptional act of kindness above and beyond their profession.
- ♥ Has not been a prior recipient.
